Crime? Nicky reported from Lake Spivey Community Meeting with 30 subdivisions that make up Lake Spivey Community. Crime not prevalent at this time. None in Spivey Glen reported over 2018.

Overnight Street Parking/Henry County Code Enforcement: some discussion as to what constitutes HC Code Enforcement: Overnight street parking is a HC Code Violation. Needs to be reported to HC Police/Non-Emergency number. HC Codes can be found on county website.

Burning/Trees: Trees over 10 inches diameter should not be removed unless have discussed with SGHOA Board President (Nicky) and/or Board members as to why need removed. Burn Ban is regulated by Henry County. Usually burn ban is May 1-Sept. Check county website.

Safety in neighborhood: member reiterated to be watchful at all times. Do not relax with homes, cars, keeping locked and secure at all times.
